- The Designated Resident(s) must reside in Park Island and travel regularly by the designated services, authorized by the Designated Applicant, and complete this application form for verification and **endorsement by Kai Shing Management Services Limited.**
- Maximum number of Octopus Cards allowed to be registered for each residential unit is as follows:

Type of Flat	Maximum Number (irrespective of adult, child or elderly)
Studio or One bedroom	Three Octopus Cards
Two bedrooms	Five Octopus Cards
Three bedrooms or above	Seven Octopus Cards

- The Designated Resident(s) should bring their Octopus Card(s) together with the verified application form to the Company for approval and registration. Discount via the Octopus Card(s) having the above card number(s) will normally be effective 3 working days after the successful registration. The Company accepts no liability for any delay or loss in relation to the registration of Octopus Card(s) under the Scheme.
- An administration fee of HK\$50 shall be charged for the initial registration of each Octopus Card and HK\$20 for subsequent change of registered data of each Octopus Card in same unit.** The administration fee shall be paid to the Company either by cash or a cheque made payable to “Park Island Transport Company Limited”.
- Concession in respect of the Octopus Card(s) having the above card number(s) will be terminated immediately without prior notice if the Designated Resident(s) do(es) not reside in Park Island or the Designated Applicant is no longer a flat owner of Park Island. **If the Designated Resident(s) move to another flat, the Designated Resident(s) must also re-register the octopus card(s) in new flat. The registration will be regarded as the initial registration.**
- The Company reserves the right to amend the above terms (including the rate of discount, cancel this Scheme at any time) without prior notice to Residents or Applicant. In case of any disputes, the decision of the Company shall be final.
